Swallowed: If poisoning occurs, contact a doctor or Poisons Information Centre (Ph 131 126 Aust. wide). If swallowed, do NOT induce vomiting. Give a glass of water. Rinse mouth with water. Never give anything by mouth to an unconscious person.

Eye: Immediately hold the eyes open and wash continuously for at least 15 minutes with fresh running water. Ensure irrigation under eyelids by occasionally lifting the upper and lower lids. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

Skin: Remove any contaminated clothing and flush area with water. Seek medical attention in the event of irritation.

Inhaled: Risk of side-effects from inhalation is considered to be low, but if effects occur, remove patient to fresh air. Lay patient down and keep warm and rested. If breathing is shallow or has stopped, ensure clear airway and apply resuscitation. Call a doctor.
